Introduction

I am extremely pleased to represent the Prime Minister and our Government to deliver the keynote Address and Open the 2nd MSG Trade Ministers Meeting being hosted by Papua New Guinea today.

On behalf of our Government and our people I'd like to welcome and thank you all the Trade Ministers and observers and officials for making time to come to Papua New Guinea to attend the 2nd MSG Trade Ministers Meeting Seminars and to attend the Trade Fair on Friday and Saturday this week which will be opened by our Prime Minister on Thursday evening at Murray Barracks.

Our significant financial investment in preparing and hosting the various aspects of the 2nd MSG Trade and Investment Road Show and Trade Fair is because we as a Government believe the MSG and its relevance and the value it provides for its membership is at the crossroads, in as far as intra MSG Trade in concern.

Serious questions need to be asked about the future of the MSG as a Sub-Regional Trading Block. What is the current and future role of MSG and why should each member economy continue to be a trading partner in the MSG Trade Block

operating under the MSG Trade Agreement? What is the MSG Sub-Regional Group anchored on? What are its foundational pillars and its future in terms of value?

Should the MSG be a political lobby group as it was then when it was first founded, or is there potential for the MSG to evolve into a Major Sub-Regional Trading Block, that is the engine for growth within the current MSG Trading Block (PNG, Solomon Islands, Fiji and Vanuatu) or under a bigger and expanded MSG Sub-Regional Block? This is where the tire hits the road in today's MSG Trade Ministers Meeting.

While our economic, social, cultural and environment dynamics present unique challenges for our respective governments and our people, we must also appreciate we are part of a bigger global community that is opening up for free trade under a more integrated common market.

Even under major regional trade and investment blocks APEC and ASEAN individual members are moving into signing bilateral trade agreements with each other under Free Trade partnerships like Australia, New Zealand and China who have signed after years of negotiations.

As a member of APEC and especially when PNG will for the first time host APEC in 2018 and therefore graduate into the league of major developing economies, we are seriously rethinking our position of trade and investment within APEC because we are dealing with critical issues like access to bigger markets, Aid for Trade especially to improve connectivity and the benefits of competition in reducing the cost of living and the cost of doing business as a global competitor. We are also seeking to process more of our raw materials including processing all our Marine Products on shore.

The point is the rest of the world is moving into a more integrated deepened and common market, based

under the rule of mutual respect and win-win partnership. The MSG has to in our view re-engineer itself and formulate a new road map with clear goals we want to pursue to remain a relevant and a much sought after Sub-Regional Trading Block, which is critical to attract new members from joining our MSG family.

ACHIEVEMENT TO DATE

I understand our officials have been busy this past week to renegotiate new chapters to be included in the proposed expanded MSG Trade Agreements (MSGTA3).

Let me state from the outset that we support a serious review with what we have achieved since 1993 when the MSG trade Agreement was first signed and revised in 2005.

After 21 years what have we achieved in terms of Trade and Investments and the value that trading amongst ourselves has contributed to our individual country's growth and economic well-being.

Have we increased Trade and Investment between our member economies, have we increased business to business connectivity, people to people connectivity and our connectivity by air and sea or remained a cultural connected group because of our success in staging the Melanesian Festival of Arts over the years.

The truth in our view is that we have had mixed success in terms of trading in goods. Our trade volumes with each other with respect are negligible. Fiji sells up to only K100 million in goods to PNG and K50 million the other way. PNG's sales to Solomon's have declined significantly. PNG only sells up to K4 million in goods to Vanuatu annually.

Why do we still do very little trade amongst ourselves in the trading of goods? Is there potential for growth and a real mutually beneficial opportunity for the MSG Trade and Investment relationship to be greater MSG integration and even expanded, deepened and taken to more MSG Trade and Investment, the next level or not under the proposed MSGTA3.

Is there political will if we all agree that there are mutual economic opportunities for our countries and economies if we chart out a new path under a revised MSGTA3? Only last year did Papua New Guinea gazette our negatives goods list which allow other MSG countries to access the PNG market without paying duty. It took a very long time to reach this point in our relationship under the MSGTA2.

The O'Neill/Dion Government by that act alone strongly signaled to the rest of the MSG that we are prepared to open up our bigger market for your goods and services. The question is should we stop here with only the trading of goods only? In a rapidly globalizing world, our economic prosperity is also linked to the prosperity of economies of our Sub-Regional and Regional Partners. Papua New Guinea remains the major economy in the Pacific Island Region. Our unprecedented economic growth in the recent years and anticipated high double digit growth in the coming years must ignite a new era of unprecedented prosperity for our neighbours as well.

FOREIGN DIRECT INVESTMENT

Despite a low volume of goods amongst ourselves, we have seen some significant increase in foreign direct investments from MSG Members amongst ourselves and the potential is there for future growth. PNG offers much new and exciting foreign direct investment opportunities especially in the services, tourism, manufacturing and fisheries sector like the proposed Pacific Marine Zone for the MSG Private Sector or State Investment opportunities.

For PNG we are at the cross roads as a Sub-Regional Trading Block.

We in PNG are committed to greater MSG integration and even expanded, deepened and taken to more MSG Trade and Investment, however, we fully recognize and respect that this is a sensitive issue

and we sincerely recognize the serious economic challenges each of our members face and your state of readiness to even consider serious integration as a common sub regional trading block.

After 21 years of trading under the MSG Trade Agreement for us in PNG we still have not achieved key outcomes like:

1. Agreeing on a fixed deadline to have an MSG Free Trade Area (FTA).
2. We do not have Double Tax Incentives amongst ourselves, I understand only PNG and Fiji have a Double Tax Treaty.
3. We do not have Investment Promotion and Protection Agreement amongst ourselves.

We have failed to make even travel for our businessmen and women easier in terms of connectivity because we still do not have a MSG Travel Card 21 years similar to the APEC Card.

Air and sea connectivity is mixed in terms of serious connectivity. We still do not have a harmonized customs union, to easily facilitate intra MSG Trade and Investment and our policies and negotiations are not friendly to facilitate Trade amongst MSG Member States.

The trading of goods amongst our member economies has declined significantly and the question of whether there is potential to grow intra MSG Trade and Investment and what are the building blocks to do that need to be discussed in your meeting today because the trade volumes are so small and may I specifically say insignificant compare to our trade with other economies within the greater Asia and Pacific Region.

We all understand our economies are anchored on different industries within MSG so our needs and challenges are different given our unique peculiarities.

THE WAY FORWARD

Clearly the trading of goods alone will therefore on its own be difficult

to support the continuation of robust MSG Trade Agreement. Unless we are all committed to greater MSG Trade and Investment it will become increasingly difficult to justify our partnership under the MSG Trading Block.

The option for Bilateral Trade Agreements is a serious option for countries within MSG to pursue unless we can craft a new revitalized MSG Trading Block that has value and is attractive for current and new members. For PNG, a revised MSG Trade Agreement (MSGTA3) must at minimum include the following:

1. A fixed date when all member economy must agree to zero tariff across the MSG market. We propose by 2017 at the absolute latest.

2. In addition, PNG will find it difficult to commit to a MSGTA if all members do not agree to signing up a double tax treaty and Investment Promotion and Protection Agreement (IPPA) 2016.

Members cannot have it both ways. If members are not committed to go all the way by removing all tariff and non-tariff barriers and agreeing to taxation reform and protecting the investment of MSG member economies in our member States then it will be difficult to en-

gage under the proposed MSGTA3.

I also proposed that you decide on the possibility of introducing a new MSG Travel Card to enable our business people to move around freely. I believe that these are the tangible outcomes that we need to pursue towards realizing our leaders vision for an integrated and unified customs union and common market.

In a nutshell, the MSGTA3 must be negotiated in the spirit of Melanesia to give us legal certainty on fairness, transparency and reflective of our common interests based on shared values, resources, expertise and wealth by allowing free movement of goods and services amongst members.

Also clearly recommend to leaders a friendly dispute resolution a mechanism system for solving our problems.

FUTURE

For the future continued staff and non-tariff barriers must either be removed permanently by a fixed date and reciprocal trade and investment must be built in an environment of openness and mutual respect and trust as core pre-requisites.

We need genuine friends and reciprocity if we want to cultivate this

relationship and our true colours will show in the MSGTA3 negotiations that our officials have been working hard on.

CONCLUSION

The responsibility on you here at the MSG Trade Ministers Meeting is to define the future of the MSG as a serious Regional Trading Block.

Do we add anew chapters and take MSG Trade and Investment to the next level or we resort to Bilateral Trade Agreements if member economies see a win-win opportunity to do business with each other.

Our future hangs in the balance and now in the hands of you my goods Trade Ministers and officials gathered here today.

In PNG we are committed to the MSG Trade Agreement but we need similar commitment and good will from other MSG Member States. We are obligated to our Melanesian brothers and sisters.

We share the common roots and are committed to growing and deepening and expanding our intra MSG Trade and Investment efforts towards arriving at a MSG Free Trade Area by 2017. This will not happen unless there is the political will and a genuine desire by the founding

members in PNG, Fiji, Vanuatu and the Solomon Islands, before we can seriously invite our observers to today to join us. We must firstly convince ourselves that there is mutual benefit for us remaining engaged in a Sub-Regional Trading Block.

For us in PNG this Trade Ministers Meeting must decide whether we expand and deepen on the current MSG Trade Agreement. For PNG we cannot add chapters to the current on MSG Trade Agreement (MSGTA2) without agreeing in this MSG Trade Ministers Meeting the following as minimum:

1. A year and from date to have all MSG Countries agree to have Free Trade Area. PNG proposes by December 2017.

2. That all members sign both a Double Tax Treaty and Trade Promotion and Trade Protection Agreement. PNG proposes by December 2016

The onus in your meeting today is to redefine the intra MSG Trade future and I challenge you all to rise up to the challenge before you today.

A new MSG Travel Card to facilitate more inter MSG Trade by making it easy for our businessmen and women to travel amongst our countries to do business will be a good

starting point.

We need to also seriously consider and revive the annual Melanesian Soccer Cup to deepen the sports connectivity amongst ourselves and increase Student Scholarships, to improve our people to people connectivity.

We fully support the need for a shipping study to assess the commercial viability of settling shipping services amongst our member countries and an expanded MSG network. Air Services Agreement amongst MSG members need to be serviced and encouraged. We are prepared to provide funding support for the crucial MSG Shipping Studies.

I look forward to come solid outcomes from your meetings today that will redefine and provide a solid platform for the development of a more deepened and expanded Trade and Investment partnership between our current MSG Member States and potentially expanded MSG network including our new exciting frontiers of West Papua Province of Indonesia, New Caledonia and even Timor Leste.

It now gives me the pleasure great pleasure to declare the 2nd MSG Trade Ministers Meeting Open.

Faiyaz Siddiq Koya, Minister for Industry, Trade and Tourism Republic of Fiji, Mr Victor Tutugoro, Chair of the MSG and the spokesperson of the FLNKS, Mr Yvon Faua, Representative of the FLNKS to the TMM, Special Guest Mr Marion Henry, Secretary, Department of Resources & Development from the Federated State of Micronesia (FSM), Special Guests Governors from West Papua, Indonesia, Permanent Secretaries, Director Generals, Directors of Government Ministries/Departments in Member Countries, Distinguished Delegates, Director General and Staff of the MSG Secretariats, Ladies & Gentlemen.

I am deeply honoured to welcome you all to the 2nd meeting of the MSG Trade Ministers here in Port Moresby, Papua New Guinea and this is the first time we are hosting the Trade Ministers, on the eve of the 2nd MSG Investment Roadshow and Trade Fair.

It is an honour and privilege as the Minister responsible to welcome you to our beautiful country, on behalf of the government and people of Papua New Guinea.

As your host and the Chair for this Meeting, it would remiss of me not to reiterate the challenge presented to us by the Deputy Prime Minister of Papua New Guinea. I believe this is the way we want to move forward into the next 25 years.

The MSG Agreement has evolved over time and the need for us to 'take it to another level' with the core objective of economic development and integration. To move forward and further integrate, we need to seriously embrace and yardsticks that our Deputy Prime Minister highlighted and as the Chair I believe we can achieve a lot together if we put in place agreements that promotes and protects our investments, avoid double taxation, improve both air and sea connectivity to better enhance movements of our business people and cargoes, thus enhancing economic growth in our countries and within the region.

Trade and Investment are key objectives of the MSG Trade Agreement amongst other areas and the MSG's vision for the next 25 years focuses on Economic Co-operation and Integration and will remain as the forefront of our objectives and this is the reason why we are all gathered here today to make decisions.

Essentially, Trade has and will always be the key pillar for Socio-Economic Development for every nation including the MSG countries either bilaterally or collectively (multilaterally) in groups in free trade areas. Its conception can even be traced back in time and is also evident in the Old Testament.

As it is crucial for any economic development regardless of size and power, the MSG thus has grasped this as a key pillar since its birth in 1988, in Port Vila, Vanuatu. The widening of the trade agreement also adds another mile-

stone to include potential partners with similar aspirations such as the Front de Libérale Nationale Kanak Societies (FLNKS) of New Caledonia, (observer in the MSGTA), West Papua province of Indonesia, and the East Timor, in the MSGTA which would eventually make the MSG Block even bigger and stronger within the pacific region.

Since the signing of the first MSG Trade Agreement in 1993 and thereafter, members have committed themselves to enhance its trade and economic relations by reducing duties to zero over 8 years from 2005. Last year (2013), PNG and two other members that are Fiji and Vanuatu had been trading duty free – which marks a positive move.

The National Gazette of 13 September 2012 saw the signing of the MSG negative list by the governor general of PNG, this reinforced PNG's commitments under the MSG Trade Agreement. Almost all of these goods listed under PNG's MSG negative list have all been reduced to zero over the 9 year reduction schedule. However, only sugar is still attracting tariff at 35% but this is subject to further reduction and all the other goods should be zero duty since January 2014.

The current re-negotiation of this MSGTA also represents a significant shift from the current goods-only agreement to Incorporate Service and Labour mobility and investment. This will open the door for greater Sub-Regional Integration which has already begun in other areas such as the skills movement scheme (SMS) amongst members of the MSG.

The SMS sets the framework for the movement of skilled MSG nationals to fill skills shortage in MSG member countries. As the Chair of this meeting, I encourage us to support our officials to explore better

ways to integrate this scheme into our trade agreement.

The challenges of trade imbalances among members must be addressed through amicable collaboration and cooperative manner as demonstrated by Fiji and Vanuatu over the issue of safeguard measures that Vanuatu imposed on chicken products.

Ministers and Head of Delegations, the convening of the Inaugural TMM thereafter in May 2013, could not have come a better time as that was the year that opened a new chapter in the life of the MSG trade agreement.

A month after we met, the MSG leaders during their 19th Summit in Kanaky/New Caledonia congratulated Fiji, PNG, Vanuatu for the reduction in duties on goods in the negative list to zero which we are currently trading under and they also welcome Solomon Islands proposal to revisit timeline for its tariff reduction schedule. This was a milestone achievement, considering that 2013 was the Silver Jubilee Anniversary of our young and vibrant organization.

Leaders further noted the particular needs of some of the members and the importance of ensuring a level playing field including the need to provide trade capacity building for the private sector in order to benefit from the larger regional market.

The leaders also approved the revision of the MSGTA rules of origin (ROO) handbook to incorporate PNG's MSG tariff schedule as gazette on 13 September 2012, approved the MSG cooperation framework on quarantine and bio-security for subsequent signing by MSG agriculture ministers, and approved that trade officials explore trade links with New Caledonia.

I understand that in August this

year, the Government of Vanuatu led a team of private sector officials from member countries to New Caledonia to show case what MSG countries have to offer. I congratulate you members on this approach and look forward to receiving updates from you all on your findings in New Caledonia.

Likewise, I am looking forward to hearing from our brothers and sisters from Kanaky/New Caledonia on what they thought about the event and the benefits the trade expo will bring to Kanaky/New Caledonia Trade and Economic Relations with the rest of Melanesia.

The approval by leaders of the draft MSGTA3 legal text including its proposed architecture, as the basis for the negotiations of a new and contemporary legal framework for broader and deeper Trade and Economic Relations amongst MSG members.

I am looking forward to (1) the report of the Trade and Economic officials meeting (EOM), (2) on the progress made on the revised draft legal text; (3) including the development of a roadmap of the draft MSGTA3 and the timely conclusion of the negotiations by the end of 2015. I understand that the revised text will serve as the basis for a new broader framework on Trade and Economic Co-operation amongst MSG members.

On the issue of kava exports, our combined political efforts has seen some positive developments over the past years in obtaining Regional and International market access for kava to the European Union (EU). Within our neighborhood, we have not been too successful in our communications with Australia to withdraw their unjustified restrictions.

in 1993 is now beginning to not only leap forward through roadshows and trade fairs, but also opens the way forward to better understand the role of private sector and the need for our Governments to facilitate.

I am grateful to member countries for ensuring that members of your private sector are present this week in Papua New Guinea to witness and participate in what I hope to be the largest and best Investment Roadshow and Trade Fair in our Region.

As the MSG works towards deepening the level and degree of Economic Integration and Cooperation of the Membership over the next 25 years, we hope the 2nd Investment

Roadshow and the Trade Fair will be the beginning of our combined efforts to achieve our objective for economic prosperity.

As this point, I would like to request the Secretariat and Members to circulate copies of the keynote statement made by my Deputy Prime Minister which I believe is self explanatory and carries the GIST of further MSG integration and this is the way PNG wants to engage with MSG countries. PNG and Fiji has already begun the journey by signing a double taxation treaty. We expect others to follow.

Welcome remarks by Mr Peter Forau Director General MSG Secretariat

Honourable Ministers of trade in our MSG Countries, Our Distinguished Special Guest, Permanent Secretaries, Director Generals, Directors, Distinguished Delegates, Secretariat Staff, Ladies & Gentlemen.

On behalf of the Secretariat and members, and on my own behalf I would like to express my sincere gratitude to Minister Maru and the Government of Independent State of Papua New Guinea for their gracious hospitality and for the excellent arrangements that have been made for the events that are happening here in Port Moresby. I wish to commend Minister Maru for his leadership of a great Team and the enormous support your government had granted to the Secretariat and members enabling a wider participation in the different meetings and events this week. I am also very thankful to our partners the European Union who have rendered their support towards capacity building of our Officials under the PITAP. I thank the EU for their support which has also enable the MSG Secretariat to recruit new staff to provide technical support and advise and consequential overall support by the Secretariat towards servicing of our meetings.

Your meeting has been convened at an opportune time, a time when the MSG is embarking on an exciting journey towards a new vision endorsed by our Leaders last year "An MSG community that is democratic, strong, integrated, enlightened, happy, prosperous, secure and caring". Within this Vision lies four objectives the one more relevant to our gathering today, is that of Economic Prosperity, that is for the MSG to create an environment for increased investment and trade as a fundamental pre-requisite for achieving sustained economic growth.

As we are all aware, our Melanesian economies are the largest with huge potential for lifting the standards of living and well-being of our citizens. Among the efforts to exploit that potential has been the establishment of the MSGTA in 1993 to promote intra-MSG trade and strengthen economic co-operation amongst MSG member. Since 1993, we have achieved major progress in our strengthened cooperation. As we gather here, times are changing, global economic integration is rapidly expanding and our coun-

tries must find our position on the global front.

Sirs, without repeating what the Chair has clearly articulated order of our business today, I wish to commend the work of the Trade and Economic Officials in deliberating over the key trade and economic issues in particular the revised MSG Trade Agreement in the past week. Ministers, our progress so far can be attributed to their hard work and deliberations. There are key issues that have emerged from their deliberations that members must pursue to achieve our goal of completing the new Agreement by 2015. However, we are also of the diversities within our members and must ensure that all parties regardless of their level of

development also benefit under the new Agreement.

Whilst we are progressing on the technical part, we must also place greater emphasis on how we are assisting our businesses to effectively participate and enjoy the benefits of the Trade Agreement. I am glad to report that the Heads of Investment and Promotion Agencies last week had discussed these very issues not only looking at large businesses but Small and Medium Enterprises, identifying key factors essential for their capacity building, strategies to enhance their competitiveness in the global marketplace, key components relating to their export success, and their role and importance in facilitating regional economic development.

Furthermore, the strengthening of the public and private sector dialogue is another initiative to foster greater regional integration, improve competitiveness, and expand the benefits of the Agreement, with special attention to SMEs and Indigenous Businesses which are often at a disadvantage because of TBTs.

Looking beyond the MSG, we believe that the time is also opportune for the MSG to deepen and broaden our economic integration not only within ourselves but also with our potential partners beyond our Region looking especially to China and greater SEAN members. We should look at the opportunities that PNG's membership to APEC could provide for our other members and strive

further to boost the confidence of businesses beyond our region. We note with appreciation the willingness of PNG to consider inviting MSG Members as observers to some of the planned APEC workshops for the coming years beginning with 2015.

MELANESIAN SPEARHEAD GROUP (MSG) PORT MORESBY DECLARATION ON "SECURING FUTURE MSG PROSPERITY THROUGH TRADE AND ECONOMIC INTEGRATION"

PREAMBLE

We the Trade Ministers of the Melanesian Spearhead Group (MSG): Independent State of Papua New Guinea (PNG), Solomon Islands, Republic of Vanuatu, Republic of Fiji, and the Front de Liberation Nationale Kanak et Socialiste (FLNKS) of New Caledonia (Observer to the MSG Trade Agreement) at the 2nd MSG Trade Ministers Meeting held on 26th November 2014, Port Moresby, Papua New Guinea.

RECOGNISING that deepened trade and economic integration is critical to secure the future prosperity of the MSG region and noting the need to improve the current MSG Trade Agreement;

RECOGNISING the original vision of the MSG to advocate for the entire decolonization and freedom of Melanesian Countries still under the colonial rule;

RECALLING the Agreed Principles of Cooperation signed by MSG Leaders on 14 March 1988 in Port Vila, Vanuatu on economic and technical cooperation;

REAFFIRMING the commitment in the Agreement Establishing the MSG signed on 23 March 2007 in Port Vila to develop stronger political, cultural, social economic and trade cooperation in the Melanesian region to strengthen traditional links between the people and communities of Melanesia;

RECALLING the revised MSG Trade Agreement that was signed in 2005;

RECALLING the Outcomes of the Inaugural MSG Trade Ministers Meeting (TMM) held on 230 May 2013;

REAFFIRMING the objectives of the MSG 2038 Prosperity for All Plan towards economic integration and prosperity for the people Melanesia;

NOW DECLARED TO RE-NEW OUR COMMITMENT ON THE FOLLOWING:

- (i) Achieving a Free Trade Area by 2017;
- (ii) Concluding MSGTA3 negotiations on Goods and Services by 2015;
- (iii) Concluding Double Tax Treaties and IPPAs by December 2017;
- (iv) Enhancing the mechanism for implementing the Skills Movements Scheme (SMS);
- (v) Strengthening MSG's customs and biosecurity cooperation in the context of the MSGTA3;
- (vi) Mapping out a clear private sector development strategy by 2015;
- (vii) Enhancing MSG Connectivity through the MSG Travel Card by 2015;
- (viii) Fund and conclude a MSG Shipping study by end of 2015;
- (ix) Promoting investments in the MSG Roadmap on Inshore Fisheries and Management and Sustainable development;
- (x) Fostering Investment Road

shows as a means to enhance business to business linkages; and supporting the work of the Finance Ministers and Central Bank Governors and CEOs of Pension and Provident Funds on the establishment of a Development and Investment Fund and Emergency Stabilisation Fund.

Speech by Hon. Peter O'Neill CMG MP Prime Minister of PNG at the opening ceremony of the MSG Trade and Investment Fair

"Government and Business Partnership to Make Gains from Asia-Pacific Economic Integration"



HON. PETER O'NEILL

As Melanesians – trade is in our blood.

For generations, for centuries, for millennia – our Melanesian ancestors have traded and communicated across our region.

Between the vastly spread Melanesian villages - our forbears shared customs including craft, dance and music, and when they interacted they became close and joined families.

Our ancestors also built the economic links that we celebrate today at this MSG Trade and Investment Road Show and Trade Fair.

TAKING STOCK OF MSG

Melanesia is broad in terms of our geography, but united in our identity as people of common outlook.

For MSG, since 1993 when the first Trade Agreement was signed, we have been working towards opening our borders to recreate the free movement of goods, people and ideas in a way that generations past could not have imagined.

But in the modern world, this can be a long and challenging process to negotiate.

Yesterday, at the Trade Ministers' Meeting, Papua New Guinea's Deputy Prime Minister, Grand Chief Leo Dion, put a very serious question to Ministers.

He challenged ministers to think about the future of MSG as a Sub-Regional Trading Block.

Deputy Prime Minister Dion asked: "What is the current and future role of MSG and why should each member economy continue to be a trading partner in the MSG Trade Block operating under the MSG Trade Agreement."

That is a very valid and important question. It is a question that every multinational forum should ask itself. It is also a question that the business community asks as it listens to discussion of free trade agreements.

After all...we do not attend these meetings such as MSG for the cocktail functions, we do not just attend these meetings for the networking opportunities.

No, we attend these meetings so we can build trade and exchanged between our countries.

We attend these meetings so that

we can create business, so we can create jobs and so we can open opportunities for men and women to better enrich the lives of their communities.

LINKING MSG TO THE ASIA-PACIFIC THROUGH PAPUA NEW GUINEA

Ladies and Gentlemen, Even before I further mention our global potential as the Melanesian Spearhead Group, we have to think about who we are as a family of MSG nations.

We have achievements to be proud of – increasing business-to-business engagement, connecting people through air and sea. As we saw at the Melanesian Culture and Arts Festival in Port Moresby this year, we are also a forum for cultural exchange.

But tonight we are discussing trade and investment in our region.

Deputy Prime Minister Dion made the point that we still have very little trade amongst our member countries.

We need to change this – we need to trade more among MSG countries.

Papua New Guinea is looking to working through the challenges still to be resolved and moving forward to the creation of an MSG Free Trade Area.

Greater economic integration and the creation of an MSG FTA brings with it enormous opportunity for the people of our region.

It will generate jobs in each of our countries, and facilitate the mobility of labor to work between across borders.

But a very important point for MSG member countries, is that through Papua New Guinea's membership of APEC, you will be able to leverage greater access to the broader Asia-Pacific market.

When we achieve an MSG Free Trade Area, Papua New Guinea takes the views of this grouping into our discussions with APEC members as we seek to create a Free Trade Area of the Asia-Pacific.

Papua New Guinea will advance our economic integration into the Asia-Pacific region in consultation with our Pacific partners, and we will share the gains.

As we prepare to host APEC, we will ensure that the interests of our Pacific Island States are considered when Asia-Pacific leaders meet each year including the meeting in Port Moresby in late 2018.

CONCERN WITH ECONOMIC INTEGRATION

Ladies and gentlemen, we know that economic integration and the removal of tariff and non-tariff barriers can be a source of concern for some businesses.

Businesses in Papua New Guinea have expressed reservations when it comes to increased economic integration...and they are right to raise these concerns for us in government to consider.

They rightfully ask, how can a medium sized producer in Lae com-

pete with a company making a similar product in Shanghai.

This is a valid point. Just across the border in Indonesia we saw serious business problems when the ASEAN-China Free Trade Area came into effect in 2011 and the market was flooded with Chinese imports.

Rest assured that governments do learn from experiences such as this, and we do not take the signing of international agreements lightly.

There are serious implications in these agreements and our role as leaders and as governments is to promote the businesses, jobs and local economies of our people.

Government must consult with business, we must seek the views of business and we must move forward with business together in partnership when we reach agreements in the international arena.

This does not mean that business can take it easy and become slack or uncompetitive, no – we need our businesses to be competitive. Business must continue to invest in itself and grow through the use of new technologies and new processes.

Where businesses are not competitive, we as governments need to help business to evolve and adapt – this is in the national and the re-

gional interest.

Because, ultimately, global economic integration is bigger than any country.

We cannot stop global economic integration for one simple reason – our citizens do not want us to stop.

Our people want to be able to buy phones, televisions and other consumer goods that are made overseas – and our people also want to sell their goods in overseas markets.

This is the way of the world. With this in mind we can do everything within our power to ensure global economic integration is good for our people and good for our business.

Working in partnership between the government and private sector, we can identify industries and sectors that are not yet ready for global exposure and work strengthen capacity, guide structural reform and to adjust timelines where appropriate.

Too often public-private partnership is concept talked of in the context of business helping the government in the delivery of services.

But as our countries open up to the world, partnership between the public and private sectors is also about governments doing our best to help businesses to adapt the global economy.

Ultimately, governments and businesses in our region must move forward together with one voice – we are partners.

Our MSG brothers and sisters must sit around our family table and work out our any differences we have and set about achieving an MSG free trade area.

CONCLUSION

So in conclusion, my message to business and investors in the MSG region, is to be clear in sharing your concerns and views on the creation of an MSG Free Trade Area.

Do this from the perspective of partnership, be prepared to compromise, be prepared to evolve and be prepared to take advantage of the opportunities that come from regional economic integration.

Working together, business and Government will create new opportunities for trade, jobs and prosperity for the people of our region.

I wish you every success at this trade and investment fair, I hope you generate new business, and for our visitors, I hope you enjoy your stay in Papua New Guinea.




